

This charming ranch home features a complex roofline of hips and gables that lends interest to an otherwise simple design. Earth-toned composition shingles cover the structure, punctuated by a brick chimney to the rear of the front wing. The front wing features a hipped or pyramidal roof, over a boxy stucco-clad body, accentuated by brick foundation work. A three-sided bay extends into the front yard, featuring double hung windows. The primary body of the home features a hipped roof capped in a small gable that extends above the main roofline. The stucco cladding on the body extends to the cement porch floor, with no brickwork. Twin bands of wooden double hung windows sit at eye level on the façade, typical of the ranch style orientation for higher windows and a more horizontal fenestration pattern. The roofline extends beyond the body to shelter the entry porch, which runs along the primary body of the structure, to the entry door sited on the north wall of the front wing. A mature shade tree shelters the property, and foundation plantings accent the yard. Overall condition of the property is good, and the architecture is appropriate to the streetscape of similar homes from that period.

In November 1936, Building Permit # 4705 was issued to Georgie W. Williams to erect a new dwelling valued at \$3,000 on a lot at 506 S. Ohio Street. Georgie Williams was a married woman, who purchased the property in her own name. She was married to Byron Williams, a carpenter/house builder. They lived in Anaheim with their daughter Ruby. The Williams family appears to have built the house on Ohio on "spec" and then sold it to E.L. and Daisy Ford on April 24, 1937. Elmer L. Ford worked as a Plant Superintendent at Independent Fuel Supply Company, likely one of the local oil companies that sprang up in that period. The Fords lived in the house until August 13, 1951, when they sold the house to Samuel and Loretta Guinn. The Guinns remained in the house until at least 1952, when the Chain of Title mysteriously drops the ownership records. When Ownership reappears, the house has passed to Mercedes Humphreys, a married woman as her sole and separate property. Mrs. Humphreys sold the house to James and Emma Turney on August 23, 1954. On February 10, 1955, Schuyler and Arline McLaine bought the house, however the marriage failed and on September 16, 1957 Schulyer granted ownership to Arline. On April 17, 1962, Ms. McLaine sold the house to Theodore and Aleeta Smith. The Smiths later moved to Hemet, California, a popular retirement community, and on July 5, 1984, they quitclaimed the house to Frank Benjamin Smith and his wife Linda Jean, very likely a transfer from parents to their son and daughter in law. On April 2, 1987, the Smiths sold the house to Michael and Darla Gualtieri. On November 9, 2000, Chris Kellogg bought the house, and on June 13, 2002, Chris added his then fiancée Jennifer Osika to the Deed. Chris and Jennifer are now married, and enjoy this cozy home together.


